Officer Nominations

The Session of Faith Presbyterian Church has opened nominations for the offices of Deacon and Deaconess until January 31, 2010. During this period of time you may submit the names of up to three men and/or women for Deacon and Deaconess. **Three (3) non-family nominations are required for nomination.** Those who are nominated and agree to serve will be given special training by the Pastor. Those nominees examined by the Session and deemed qualified for office will be presented for election by the congregation early next year.

Deacons are mature Christian men who have been elected and ordained by the congregation to oversee matters related to the physical needs of the ministry and its members. Deaconesses are mature Christian women who have been elected by the congregation and commissioned to serve with the Deacons, especially in support of the mercy ministries of the Church. The Deacons Board directs the mercy ministries of the church and cares for the physical property of the congregation; it meets once each month to plan and coordinate the diaconal ministry.

According to the Constitution of the Presbyterian Church in America the office of Deacon “is one of sympathy and service, after the example of the Lord Jesus; it expresses also the communion of the saints, especially in their helping one another in time of need.” (Book of Church Order 9.1)

The Apostle Paul wrote about the qualifications for the office of Deacon in 1 Timothy 3:8-13, and the specifics of diaconal ministry and duties are set forth in the Book of Church Order, 9.1-7.

Members are urged to study these qualifications carefully, pray for God’s wisdom, and nominate those they believe should serve the Lord in this office.
